PLEASE READ BEFORE OPERATING!!

- Hydra Sled must be fully retracted prior to operation of the Dove Tail. Failure to do so could result in damage.
- Sled and hinge should be greased every 10 cycles.
- Battery must be fully charged and checked periodically. Trailer battery charges when connected to towing vehicles. Charge wire must be active.
- Check all lug nuts and suspension bolts to make sure they are tightened.
- Check tire pressure in all tires.
- Safety chains must be attached to your vehicle to avoid damage to vehicle, trailer, or self.

Routine maintenance is essential to ensure your trailers performance and reliability.

Failure to follow any of these can void your warranty.

EZ-Haul , Red Rhino, and Orange Ox Trailer Warranty

Terms and Conditions:

Your EZ-Haul, Red Rhino, and Orange Ox Trailer is warranted to the original purchaser to be free from defects in material and workmanship, for a period of 3 years on hay trailers and 2 years on flatbed trailers, except as herein limited, from the date of purchase. This warranty will also cover trailer wiring for 6 months from date of purchase. The obligations of T&B Welding and Trailers Manufacturing, LLC (the company) under this limited warranty shall be limited to repairing or replacing any part or parts which, in the opinion of the Company, shall be proved defective in material or workmanship under normal use and service during the 2 or 3 year period commencing with the date of purchase. This warranty does not cover any part or parts which have been damaged as a result of an accident, misuse, abuse, or which have been modified, altered, or repaired by anyone other than T&B Welding and Trailers Manufacturing, LLC. This warranty shall not apply if the trailer has been subjected to loads in excess of its rated capacity, the remedies described herein are the sole remedies.

EXCLUSIONS AND LIMITATIONS:

EXCLUSIONS

This Warranty shall not extend to:

- 1) Any trailer or component for which the warranty registration card was not returned to T&B Welding and Trailers, LLC.
- 2) Equipment which has been modified, repaired, altered in anyway without the express written consent of T&B Welding, LLC.
- 3) Unreasonable use (including failure to provide reasonable and necessary maintenance).
- 4) Tires, axles, axle assemblies, suspension components, or any other equipment which is warranted separately by the respective manufacturers of said components.
- 5) Parts not supplied by T&B Welding and Trailers, LLC.
- 6) Parts which require replacement in the ordinary course of use due to normal wear.

WHAT YOU MUST DO:

In order to make a claim under these warranties:

- 1) You must be the original purchaser of the trailer.
- 2) You must properly notify T&B Welding and Trailers, LLC within the warranty period of any defects and provide T&B Welding and Trailer, LLC with any substantiation that T&B Welding and Trailers, LLC may reasonably request.
- 3) The trailer must have been used and maintain in accordance with good industry practice and the recommendations of T&B Welding and Trailers, LLC.

LIMITATIONS AND EXCLUSIONS:

- 4) Warranties are non-transferable
- 5) THE WARRANTIES ARE EXCLUSIVE AND THE REMEDIES PROVIDED THEREIN ARE THE SOLE AND ONLY REMEDIES
- 6) THERE ARE NO WARRANTIES, EITHER EXPRESS OR IMPLIED INCLUDING THE IMPLIED WARRANTIES OF MERCHANT ABILITY AND FITNESS FOR A

PARTICULAR PURPOSE WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF.

7) Except as maybe prohibited by law, T&B Welding and Trailers, LLC, shall not be liable for INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND OR DESCRIPTION INCLUDING BUT NOT LIMITED TO LOSS OF TIME, PROFIT, INCOMBENIENCE, LOSS OF USE, TOWING FEES, TELEPHONE CALLS OR COST OF MEALS OR LODGING.
